LINKS WITH THE COMMUNITY

Finally with the lifting of any remaining Covid restrictions we have re-established old links with external speakers for our Personal, Social and Health Education (PSHE) programme and also developed new partnerships. Having experts in their fields speaking to learners and engaging them with important issues is a key feature of our provision and so we are delighted to be able to invite them back into school. It is also via these lessons that our Police Liaison Officer builds relationships with our learners which, of course, benefits the community.

We have recently engaged with Careers Wales on an Alumni project, which aims to bring old Lliswerry High School learners back to speak to current learners about careers and opportunities available to them.

Our long awaited Friends of Lliswerry group is now up and running, with key priorities of encouraging donations to our preloved uniform shop and also raising funds to enhance our sports provision. We will also be looking at supporting the local community through this group with fundraising events.

Doing our bit for charity is a key feature of school life and already we have collected a vast amount of food for Raven House food bank and lots of money for our day of activities for Children In Need. We have lots more charity events planned for this year both supporting local and national charities.

Our newly employed Family and Community Engagement (FACE) Officer has started in her position and is already making strong links with families and other key stakeholders across our cluster.

SPORT

Extra-curricular sporting activities have now fully resumed and we are now offering a wide variety of clubs available at lunch times and after school. We are now able to mix different year groups together which means numbers have increased. The current clubs that we have are netball, basketball, badminton and football all continuing to prove popular.

PE lessons have continued with classes back in their original sizes which allows for greater variety of activity. We continue to be outdoors whenever possible but a well ventilated sports hall has allowed indoor sports to continue. We finished off the year with a highly successful sports day with a range of athletics and other physical events involving all year groups and some staff.

As learners now have access to all areas of the yard and field, our learners are making full use of the outdoor gym equipment and it's Yr 7 who seem to find the trim trail the most fun. The dry weather at the start of the school year has also meant that learners could access the field at every break and lunch time to maximise their physical activity. The seven Gol pitches are used every lunchtime and normally over a hundred learners take advantage of this every day.

CURRICULUM

In years 7, 8 and 9, learners are taught in their form groups with the exception of some practical subjects where smaller groups are required for Health and Safety reasons. Learners who have additional learning needs are supported in their classes by a team of Learning Support Assistants. In addition, learners who require catch-up support for literacy or numeracy are withdrawn from classes to receive this in small groups.

New to English learners in years 7-9 are taught language acquisition for 20 periods a cycle in groups defined by their stage rather than age. Learners progress through groups as their language skills progress and return to their form class for all lessons once a satisfactory level of competence is achieved enabling them to access the curriculum.

In years 10 and 11, learners continue to be taught the compulsory subjects – English, Maths, Welsh, Science, PSE, PE and Skills Challenge Certificate. In addition, learners can choose up to three options to study during this two year period.

The Curriculum for Wales has been fully introduced into Years 7, 8 and 9.

The governing body approved the high level curriculum summary which is published on the school's website.

New to English learners in years 10 and 11 are taught language acquisition for 20 periods a cycle and in addition they study some option subjects. We are also continuing to develop our alternative curriculum provision for learners, both at school and at our Aspire centre which is located off site.

In the Sixth Form, learners choose from a wide range of Level 3 subjects delivered at Lliswerry High and our collaborative partner school St Julian's High School.

WELSH LANGUAGE

Welsh is a compulsory subject at KS3 and KS4 for all pupils except those who are new to English. The Welsh language is used across the curriculum for dates, headings and praise. Welsh is also used to welcome pupils to classes and assemblies and as pupils enter the school at the start of the day. In lessons, incidental Welsh may be used by teachers and learners as part of daily routines and to give instruction.

The corridors throughout the school use bilingual signage.

The Welsh team have recently launched 'Criw Cymraeg' which is an extra-curricular opportunity for learners in Year 7, 8 and 9 to promote the use of the Welsh language and culture across the school.

Bilingual staff are available on site for those who require translation or choose Welsh as their language of communication. We are also engaging the support of the EAS Welsh Advisor to assist in our development of the Welsh language.

The Languages Team and Criw Cymraeg are currently working towards the Campus Cymraeg Bronze Award.

TOILET FACILITIES

Toilets are available for learners on the ground floor and first floor. In addition, the Sixth Form have their own toilet facilities in the Sixth Form block. Toilets are allocated specifically to individual year groups linked to their use of an allocated canteen, either on A or B floor. Toilets are checked for cleanliness every hour and cleaned appropriately in the event of any bodily spillages.

HEALTHY EATING AND DRINKING

During the school day, the only food that can be purchased is in the school canteen during allocated break and lunchtimes. Chartwells, our caterers, offer a wide variety of food compliant with the Welsh Government guidelines on Healthy Eating in Schools. Water is freely available in the canteen at break and lunchtimes and at other points during the school day from the water fountains. The morning breakfast club is continuing to ensure that those learners attending start the day with something nutritious and filling.

Our PSHE curriculum continues to teach learners about the need to adopt healthy lifestyles, making them aware of healthy eating and drinking. Mental health and wellbeing is also part of PSHE, therefore promoting healthy minds as well as bodies. This is alongside the teaching in food technology and science where healthy eating is also addressed as part of the curriculum.
